Last week IHBG Grading plan accurate if everything stays the same. We are changing the deductible to per occurrence to each building. Rates should stay flat.

Board of Directors approved 15% dividend.

Region III and V are eligible for the \$20,000. Fires are the major claims.

There has been no base rate claim in awhile.

Cecelia Fire Thunder asked Derek about the different kinds of fires and claims. Derek explained.

Bob - Ted Beulow- USDA can fund fire equipment.

Chairwoman Vogel – What I heard is that we need to be creative and inclusive. Cecelia – We have a large land base.

Derek - Recruit new members and grow AMERIND \$2 to \$3 million each year.

NAIHC Report

Bob – Tony Walters is now with us.

Lafe – We have been doing virtual meetings with AMERIND.

One of the things, Tom Filesteel was my alternate. His passing shocked us all.

Jeannie – Do you have anything to add? Derek and Lafe covered everything. It would be good if your staff would set up something on the deductible.

Region III – We have a term up. Joey Nation – Northern Ponca nominated Jeannie Thompson. 2nd by Flandreau. All in favor.

Lower Brule nominated Eric Shepard for the alternate for Region III. 2nd by Northern Ponca. All in favor.

Lafe Haugen nominated Patrick Goggles to fill the unexpired term of Region V Board member. 2nd by Fort Peck. All in favor.

Tony Walters - NAIHC

We have moved to a different office on the 5th floor. T/TA – keep an eye on our website. We are catching up with trainings Tribe's requested. We try to limit the number of members. As we catch up on the trainings we had 1 or 2 travel restrictions come into effect.

Tony discussed trainings on line. Our goal is to do 2 or 3 a year. Even if travel restrictions continue we will continue on line trainings.

Bob – We were discussing advocacy before the recess. Tony is willing to do a one hour zoom in a week or two with Cecelia and her Congressional. Tony said yes.

Legislative and Legal Report

Jim W – In my 47 years in Indian Housing there has never been a year like this. Competitive, COVID 19, Cares Act and additional IHBG funding spread out at the same time. Additional ICDBG funding. As time has gone on it is apparent that additional funding was needed. Eviction Moratorium – This is the vehicle within that bill.

House and Democrats – 3 Trillion \$'s of funding. Heals act 1 Trillion \$'s. Skinny Package – Republicans are proposing 500 Billion \$'s. Working extensively over the months it had a pretty good impact.

Dave Heisterkamp
Bills called Heals- 9 different bills
2nd round of COVID

They are going to come back from their summer break. Just as this broke, 20 -21 IHBG Grant.

Provisions for TDHE, threshold capacity. 5 good Grant getters, those that had update. 5 in this Region are not prevented from putting in for.

Elimination of 30% Rule. Dave – If they were to approve Omnibus Bill. There is discussion on continuing resolution to keep the government going. We have assisted some of you. Congress is all over the map.

All West was cancelled. AMERIND continued to support the tournament.

Jim W – The Hawaiian issue has become troublesome.

Dave in relation to where those #'s came from was discussed. UNAHA has sent letters. Data sets to get accurate counts. These will start affecting allocation in 2023.

Jim W – I am concerned about the NAHASDA formula. They used the formula again, it wasn't 600 million, it was Billions of \$'s.

Chairwoman Vogel- Thank you Jim.

Negotiating Rulemaking Committee should be recovened. Bob G – I like that suggestion now that we are without Mutual Help units.

Jim W – We need a new formula not an old modified formula. If proposed and advocated make sure it is not modified. Jim W – It is such an important ongoing issue.

Bob G - California Tribes - New Rulemaking committee, MH is gone and doesn't reflect the true count.

Jim W – In the next 4 years or so our office with your support.

Tony Walters – I wasn't focused on that. Getting something done that is that controversial? There is avenues to do outside of congressional.

Bob G – I am not asking you to get in the middle of it.

Census data is not accurate. How did we get to this point?

We are not getting compensated for the remote area.

 $\lim W$ – This is no longer just an Indian Housing issue. To address this it is important to bring Tribes into the issue. Tribal Leaders and Tribal Governments should get involved.

Chairwoman Vogel – I agree- 2 separate needs. Housing needs and national census. Eliminate existing formula.

Jim W – That is our challenge, we will make the effort to gain your support.

Tony W – Any effort like this, Regions may have different levels of need.

Bob G. We should initiate a back fire.

Jim W – Alaska is not the same group of Tribes. Small Alaska
