AGRIT – We suffer from some of the biggest reinsurance. What are the proper levels? Reinsurance changes every year. We have to find someone to accept the risk. It looks like there will be a rate increase in 2024. This Region will be experiencing the lowest rate increase. Housing Authorities made some good decisions on what they were going to claim. Region III and V. Fire may not be an issue, but flooding may be. All effects of COVID. Contractors dictate their pricing, finding outrageous pricing, supply chain issues. Price to rebuild has changed dramatically. AMERIND has relied on investments to soften the blow. Should we consider starting our own Risk pool. Claims are at all time high. We do invite you to price shop. AGRIT training was a good thing.

Jeannie – It's a tough market out there. Pools nationwide are struggling with the same issues we are. We find that there isn't a clear issue. A lot has to do with weather.

Eric Shepherd – Maintenance guys, inspectors work with them, support them.

Rod -Training is important to AMERIND/NAIHC Increase the training.

Patrick- NAIHC is 5 weeks away- May 7-12. Host hotel full. Good breakout sessions. Legislative conference – Pay attention to the agenda. Round Table -US Treasury – ERA Round table discussion. 3rd Biden 24 budget has been released. Reality check, we have a split Congress. We need to work hard with advocacy. Last thing, selection committee.-Chelsea Fish -Seminole from Oklahoma was selected for NAIHC Director She will start April 10, 2023. We need to send letter of Appreciation to Tony. Next Board meeting April 10, 2023.

Patrick – 20th year at Northern Arapahoe. You need to know what FCAS is. When I started 20 years ag0. Randy challenged me on ICDBG application. You need to get with Bob or ONAP. Need a good basis of experience.

Out of HUD budgets-76 Billion \$. Indian Housing less than 1% of that budget. 780 Million -IHBG. 100 Million -Competitive, 75 Million ICDBG. T/TA – 5 Million. We are using money to maintain shovel ready. USDA- Community facilities. We learn how to administer these funds. Sovereign immunity is one of them. Primary goal -Reauthorize NAHASDA. When they come to your state, they wat t0 hear it from you.

Tiny houses-Development from the ground up. Allocation is on Code talk. Erna Reeves is Secretary, Jody Perez is Treasurer. Section VIII could replace ERA. NAHASDA #1 priority. HIP Funding 23 Million should be 50 Million. HIP program allows for down payment.

Jason – New ED for NAIHC. Before there used to be an ED and a Legislative Coordinator.

Sharon – Trying new approach with Thomas.

Patrick- We do receive a donation from AMERIND, we use it for Advocacy.

Heidi F -IH less than 1%, she suggested increase from within the budget. 703 of NAHASDA, receiving end of T/TA. NAIHC to fulfill. NAIHC is just the contractor. September board meeting -Appt, a work group to discuss the T/TA.

Patrick – 703 says National Organization. There are only 3 other organizations.

Sharon – The fix is in the Secretary's office.

Jason- We will come back to this issue tomorrow.

Consolidation process on EA's started 7 years ago.

Dave – Kayla Laywell-MSW-Hosing Policy Analyst NLIHC-Racially and socially suitable public policy. NLIHC has 1300 members. UNAHA has been a member since 2016. GAP shortage. US has shortage of 168,752 units.

Kayla -Former Senate staffer. Disaster Housing Recovery – Tribes are eligible, but never used it. State and Tribal Coalition-nonprofit.

STP- Convening – March 20-21, 2023. 3rd-where are we going together? NLIHC – 118th Congress-Emergency Rental Assistance-Eviction Crisis Act-this Congress has 500,000 Choice Vouchers under Section VIII.

Heidi position under NAHASDA reauthorization.

IHBG Competitive -Top priority. We want 6 things, create permanent rental Assistance, IHBG Competitive funding, Farm Bill, Push for IHS funding, USDA application.

NLIHC has not had any connection to IHS. ERA and HAF.

Communicating with IHS is a Housing issue.

Jason - host hotel is full for NAIHC. Associate members Jeff Clairmont-Raven Consulting Indian Preference – Fee Accountants

Administrative Report- Jason Adams

Discussion on 703 training funds issue. 703 was intentionally put into law. 1st time there was government to government. History of NAHASDA- Take care of Tribe's needing T/TA. 703 describes an organization into law. Focused on Indian Housing issues. The language is germane to the work I do. I look at ONAP level today. There was 65 to 70 employees in ONAP, today, there is 9. 500's in regulation describes HUD's role. 703 where we are at today. 3 or 4 months for T/TA is not acceptable. Chris Boesen, a lobbyist in DC. Negotiated a delayed retainer fee. Funnel money you already have through NAIHC. Training on emergency items. HUD said NAIHC knows this. You needed to know this information.

Rod T -We can change this by visiting with HUD or lobbying Congress.

Sharon – It is not just lobbying \$'s it is the split in the House and Senate. Reauthorization. Jason – DC is run by the young folks.

Patrick-Capacity building is one of the things available for training. HIUD has engaged people that aren't knowledgeable. They told me we can't do that.

McHenry-NC-House on financial services

Schaatz-HI-Senate Committee on Indian Affairs

Administration recommendation-We want to have Lobbyist at the table when that bill comes out for Section VIII instead of ERA. Create a fund to address this issue.

Jason - \$25,000. - \$500 donation. That is a point of action.

Robin T -New members to ONAP, Section VIII on CAS units, they call it double dipping. They won't listen on the intent.

Eric S – Our 2 trips a year aren't enough.

Eric made a motion to move forward on retaining a lobbyist, 2nd by Patrick, all in favor,

703 T/TA, reauthorization and anything else that comes up. Have Chris Boesen fulfill legislative issues and have reports back from Chris. Motion approved, 20 votes.

Redesigning website- Carrie, our goal is still in the works. Kia Birdsbill is redesigning our website. Revamping things. Myrna will keep you updated.

Board talked about legislation. Advocacy trip to DC, Dave will take point. Most of the time is with staffers. Sharon a lot of the time when we are up on the hill you have 5 minutes. Having a meet and greet. It would give you a chance to have a slide show, if you decided to go to DC.

Patrick- I agree UNAHA membership needs to be in DC. There are alternatives, at the end of every session of Congress, they will come back and have meetings. They want to hear from you in person. Senator Loomis-WY-We are going to support WY. Michael-Fort Belknap Board member. Now is the time for Native Americans to make things happen. We need to make a voice and look for answers. Time to have government act according to the treaties. Give us affordable housing.

Sylvia Wirba- We have to show them results, not just ask for money. Let's be shouting our strengths. Now is the time to get ahead. Putting our Housing needs out there. Let's see who wants to pursue this.

Discussion on Summer meeting location. We were hoping it would be in UT. The fall back is always Billings, MT.

Sharon- What we did last year Tribes all got together and we are going to have it in UT. Melissa – Go Chute.

We need to figure out how we can make sure NAHASDA doesn't get cut. We have a divided Congress, but we have a hostile Congress. ERA spending report. Capacity and need. USDA upgrading regulations. Regulatory without having to go statutory. Sylvia – three sets of comments. OMB comments. We want you to be able to comment, 2 CFR, part 200-OMB they're in the process of rewriting 2 CFR 200. four questions.

What specific part of CFR reducing administrative burden.

Another set of comments 184-1992 law- Federal lending on trust land-184 Tribal leaders and Tribal attorneys.

Sharon-Communications is a priority. Read your e-mails, read Myrna's e-mails.

Sylvia- Next week is the Tribal Intergovernmental Advisory Committee meeting.

Key thing you would think it would have is Executive Directors.

Rod- How long are these commitments? It is a few years.

Last comments due on Monday. Housing Counselor on staff. 2010-2011-Dodd Coalition.

As a result of this law said Housing program. Language is some consultation. What we said is you have to take an exam. Mortgage and lending

Had one client and one staff member take the test. This is going to happen in the next few years.

Robin-Pathways to Homeownership – What happened with that?

Dodd Frank Act -

Office of Housing Counseling – Sylvia – You should be able to access the training.

Rents or homebuyers – No Penalty

Current rule- 2 years ago we made our initial comments. They issued a proposed rule, modified the test.

UNAHA calls on HUD to implement increase in HUD VASH vouchers, TDHE's on a first come first serve basis.

TDHE's eligible for Section VIII vouchers on units built after 1996, including tax credits . 50 vouchers – 21 for.

Review and amend NOFA criteria -ICDBG and IHBG competitive on leveraging.

Meaningful Tribal consultation on development of Section 184 Handbook includes entire project. Dave to prepare draft resolutions.
